Characteristics of a Healthy Economy

- Capital (\$\$) invested efficiently so businesses in economy thrive
- Thriving businesses, in turn, produce products and services that society needs

Securities and Exchange Commission (SEC)

- Established by federal government 1933/34
- Today: SEC oversees over 12,000 companies listed in stock exchanges
- Requires public companies to file audited financial statements
 - Established the role of CPA who provide USEFUL info
- Has the authority to enforce non-compliance "stop order"

Issues:

- Government wanted SEC to create accounting principles
 - But they decided a private group should do it

American Institute of CPAS (AICPA)

- National professional organization
- They created the "Committee on Accounting Procedures" (CAP) 1939
 - o Part-time practicing CPAS
 - 20 years issued 51 Accounting Research Bulletins (ARBS)
 - Each ARB addressed a problem
 - o Problem by Problem approach failed

Accounting Principles Board (APB) 1959

- 18-20 members CPAs, Academics, Industry Specialists (part time but need CPA certificate)
- Issued 31 Accounting Principle Board Opinions
- Slow to address accounting abuses
- 1972 Study Group (Wheat Committee) recommended that APB be dissolved
- 1973 APB was replaced with FASB

1973—Present Day (no AICPA)

- Financial Accounting Foundation [FAF]
 - Independent Organization (Norwalk CT)
 - Selected Members of the FASB and the advisory council and Funds Activities
- Financial Accounting Standards Advisory Council
 - Consult with FASB on major policy and technical irruser
