Level 1 heading

References

References are not only vital in your printed work but are also a key feature in digital publishing, where bibliographic references are hyperlinked.

Level 2 heading

Reference check

In order to ensure this linking is possible and correct, you must:

- Ensure that all references are complete and consistent whichever reference style you are using (see 'Reference styles' in this chapter).
- Avoid *ibid.* and other similar conventions (*op.*, *cit.*, etc.); these are print-specific terms and limit effective linking of references in a digital context. (see 'Short title citations' in Chapter 4)

Heading name given for cross-reference in the same chapter. We can hyperlink directly to this heading in a digital context. An indication that this is in the same chapter helps the reader to easily locate this in the print edition.

Relevant heading and chapter no. given where the cross-reference is to another chapter. In a digital context we can hyperlink to this heading to take the reader directly to this material
