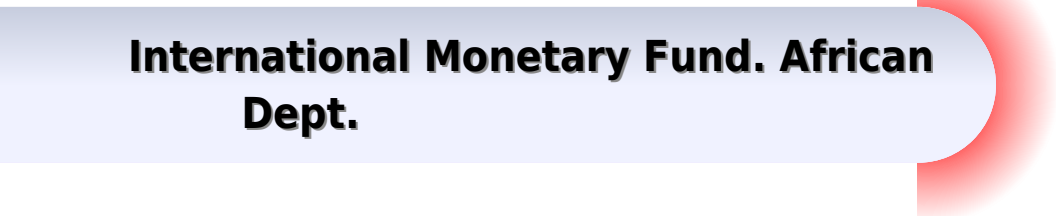
Conclusion:
