1. Capital (\$\$) invested efficiently so businesses in economy thrive
2. Thriving businesses, in turn, produce products and services that society needs

Securities and Exchange Commission (SEC)

- Established by federal government 1933/34
- Today: SEC oversees over 12,000 companies listed in stock exchanges
- Requires public companies to file audited financial statements
 - o Established the role of CPA who provide USEFUL info
- Has the authority to enforce non-compliance "stop order"

Issues:

- Government wanted SEC to create accounting principles
 - o But they decided a private group should do it

American Institute of CPAs (AICPA)

- o National professional organization
- They created the "**Committee on Accounting Procedures**" (**CAP**) **1939**
 - o Part-time practicing CPAs
 - o 20 years issued 51 Accounting Research Bulletins (ARBs)
 - o Each ARB addressed a problem
 - o Problem by Problem approach failed
- **Accounting Principles Board (APB) 1959**
 - o 18-20 members – CPAs, Academics, Industry Specialists (part time but need CPA certificate)
 - o Issued 31 Accounting Principle Board Opinions
 - o Slow to address accounting abuses
 - o 1972 Study Group (Wheat Committee) recommended that APB be dissolved
 - o 1973 APB was replaced with FASB

1973—Present Day (no AICPA)

- Financial Accounting Foundation (FAF)
 - o Independent Organization (Norwalk CT)
 - o Selected Members of the FASB and the advisory council and Funds Activities
- Financial Accounting Standards Advisory Council
 - o Consult with FASB on major policy and technical issues
