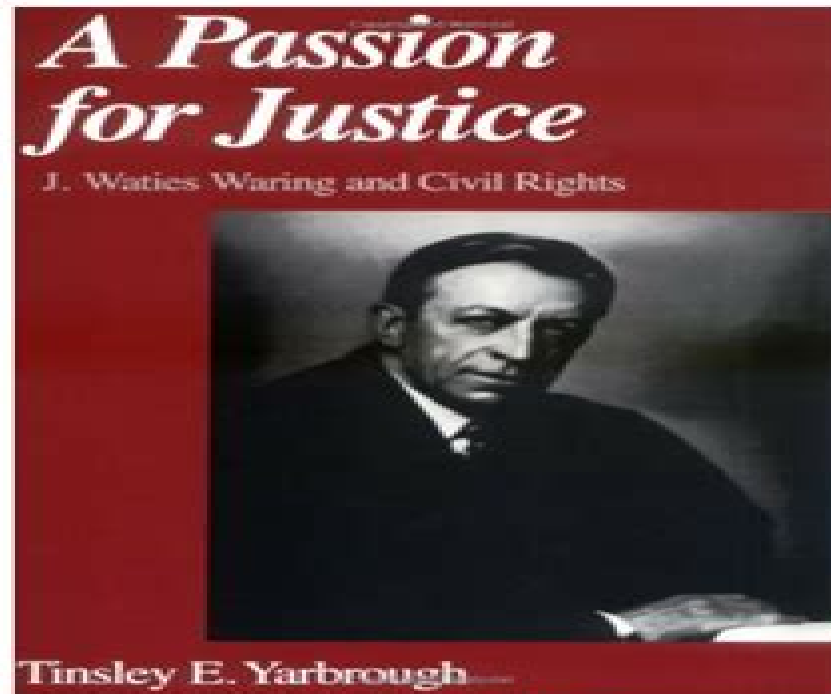

NAACP meeting on Auburn Avenue to an all white party in upscale Buckhead She eventually drops her ladies clubs and her deepening involvement in the civil rights movement costs Parsons many friends as well as her first marriage The Rhetorical Road to Brown v.
