In this manual, 'left A' and 'right B' mean your left and right when you are seated correctly in the machine.

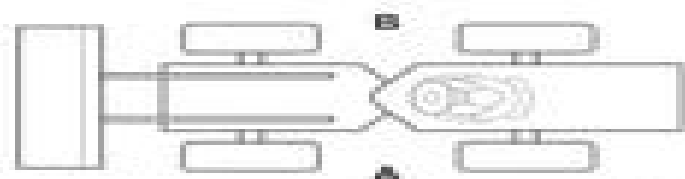
