 - Writing
- Offeror: party making offer
- Offeree: party accepting the offer
- EXPRESS CONTRACTS states the terms in words
- IMPLIED CONTRACTS are contracts implied in fact and law
 - IMPLIED-IN-FACT CONTRACTS - nonverbal conduct contract (repair shop, etc)
