 - v. Voluntary vs. Involuntary Bankruptey
 - 1. Voluntary: before debtor files a petition, must receive credit counseling
 - 2. Involuntary: debtor's creditors force debtor into
 - a. Requirements:
 - If debtor has 12 or more creditors, 3 or more creditors having unsecured claims total at least \$15,321 must join the petition
 - If debtor has fewer than 12 creditors, 1 or more creditors having claim totaling \$15,325 or more may file
