D. TWO TIET SYSTEMS/ TWO TIET ATCHILECTURE

A two-tier system consists of a client and a server. The database is stored on the server, and application used to access the database is installed on the client.

# The advantages of Two-Tier systems are as follows:

- The system performance is higher because business logic and database are physically close.
- Since processing is shared between the client and server, more users could interact with system.
- By having simple structure, it is easy to setup and maintain entire system smoothly.

# The disadvantages of Two-Tier systems are as follows:

- Performance deteriorates if number of users is greater than 100.
- There is restricted flexibility and choice of DBMS.

### c. Three Tier Architecture

Three-tier architecture is a client-server architecture in which the functional process logic, data access, computer data storage and user interface are developed and maintained as independent modules on separate platforms.

## The three tiers in three-tier architecture are as follows:

- Presentation Tier: This tier communicates with other tiers by sending data to other tiers in the network.
- Application Tier: It controls application functionality by performing detailed processing.
